The four awards are described below:

- **The UWC Outstanding Contribution Award:** This award is given to a UWC member or researcher for outstanding contributions to UWC or the National Foundation for Unemployment Compensation and Workers' Compensation.
- **The J. Eldred Hill, Jr., Award:** This award is named after J. Eldred Hill, Jr., former president of UWC (then UBA), and is given to an individual for excellence in the public policy arena in service to the employer community.
- **The UI Integrity Award:** This award is given to an individual who has demonstrated commitment to preserving the integrity of the unemployment system.
- **The Father Becker Award:** This award is named for the late Father Joseph Becker, a pioneer and scholar in the development of the Unemployment Insurance system. The award is given to an individual who has made major contributions to unemployment insurance research.
